

**PENSACOLA GREYHOUND TRACK  
\$100 BUY-IN "DEEP STACKS" NO-LIMIT TEXAS HOLD'EM TOURNAMENT**

**TOURNAMENT RULES**

1. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Tournament Rules
2. Beginning January 4, 2012, the Pensacola Greyhound Track Poker Room (PGT) will sponsor \$100 buy-in tournaments at the following dates and times:
  - a. 7:00 PM Wednesday every Wednesday through June 2012
  - b. 7:00 PM Saturday every Saturday through June 2012
3. The buy-in fee for each of the tournaments will be \$100
  - a. The entry fee for each tournament will be \$75 (100% of the entry fee will be returned to the players)
  - b. \$5 will be withheld for the Player of the Year Promotion
  - c. The administration fee will be \$20
4. Each blind round will run for twenty (20) minutes (the tournament blind schedule is available upon request)
5. Participants will receive \$7,500 in tournament chips upon entering a tournament
6. Participants will have the option of contributing \$10 to the tournament staff toke pool to receive an additional \$2,500 in tournament chips
7. Late entries, re-entries and alternates will be allowed for the first round (20 minutes) of a tournament
8. Participants must be 18 years of age or older and possess a valid ID
9. The tournaments will be conducted in accordance with the Tournament Directors Association (TDA) Rules
  - a. By participating, entrants agree to abide by the terms of these Tournament Rules and to the decisions of PGT Management and to waive any right to claim ambiguity in the tournament or these Tournament Rules
  - b. Current TDA rules are available upon request

**PAYOUTS**

1. When the tournament is down to the final table (not more than 12 players), the remaining players may agree to distribute the prize money differently than the posted payout schedule (the tournament payout schedule is available upon request)
  - a. The agreement must be reached unanimously
  - b. The agreement will end the tournament
2. 100% of the prize money will be returned to the players and will be administered and paid by the Poker Room Management

**INDEMNIFICATION AND RELEASE**

1. PGT Poker Room reserves the right to refuse entry into the tournament
2. All winners will be required to provide their name, current address and telephone number which will be stored as a record of the prize received
3. Participation in this tournament and/or acceptance of a prize payout constitutes permission for PGT Poker Room to use the participant's names, likenesses and statements for promotional and publicity purposes without additional compensation or limitation unless prohibited by law
4. The PGT Poker Room has attempted to cover every rule, procedure and circumstance that may occur during this tournament. In the event a decision is necessary that is not covered by the above, PGT Poker Room Supervisory Personnel will make that decision
5. The Division of Pari-Mutuel Wagering reserves the right to investigate any and all complaints and disputes regarding tournaments, promotions and drawings
6. Management reserves the right to cancel, change and modify tournaments, promotions or drawings with notification to the Division of Pari-Mutuel Wagering
