

**PENSACOLA GREYHOUND TRACK
PLAYER OF THE YEAR 100K GUARANTEED TOURNAMENT SERIES**

TOURNAMENT RULES

1. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Tournament Rules
2. Participants must be 18 years of age or older and possess a valid ID
3. Tournaments will be conducted in accordance with the Tournament Directors Association (TDA) Rules
 - a. By participating, entrants agree to abide by the terms of these Tournament Rules and to the decisions of PGT Management and to waive any right to claim ambiguity in the Tournament or these Tournament Rules
 - b. Current TDA rules are available upon request
4. A portion of the buy-in for each tournament will go toward the Player of the Month and Player of the Year tournaments
 - a. \$5 will be taken from tournaments with buy-ins up to \$100
 - b. \$10 will be taken from \$105 - \$245
 - c. \$15 will be taken from \$250 and up
5. The Player of the Month tournaments will be allocated \$5,000 each, and the Player of the Year Tournament the remainder, of the pooled prize money
6. Prize money and points will be audited by the accounting department

PLAYER OF THE MONTH

1. Beginning January 1, 2012, players placing in tournaments throughout a month will receive points based on the monetary value that player earns in each tournament. (e.g., if a player wins \$1,500 in a tournament, that player will earn 1,500 points toward the Player of the Month tournament)
2. The top 100 point earners each month will be eligible to play in the \$5,000 Player of the Month Invitational at the end of each month
3. A points standing will be posted in the poker room each week
4. Each player participating in the Player of the Month tournament will receive 4,000 in tournament chips at the start of the tournament, plus a 2,000 dealer add-on option
5. Prize money for the Player of the Month tournament will be paid to the top 10 places
6. All participants in the Player of the Month tournaments will be awarded points toward the Player of the Year tournament as follows: 1st place will receive 100 points, 2nd receives 99 ... 100th receives 1 point.
7. The House fee for the monthly tournament will be \$1,000

PLAYER OF THE YEAR POINTS RACE

1. A prize pool of \$15,000 will be allocated from the Player of the Year prize pool. This money will be paid to the top 10 Player of the Year point's leaders for the year
2. The prizes for the top 10 points winners will be awarded as follows: 1st Place \$5,000, 2nd Place \$3,000, 3rd Place \$2,000, 4th Place \$1,500, 5th Place \$1,000, 6th Place \$850, 7th Place \$600, 8th Place \$500, 9th Place \$300, 10th Place \$250
3. The remaining money collected for the Player of the Year will go into the prize pool for the \$40,000 Guaranteed Player of the Year Invitational Tournament (See Player of the Year)
4. The \$40,000 guaranteed for the Player of the Year Tournament will include the \$15,000 for the Player of the Year Points Race plus all other Player of the Year monies collected throughout the year

PLAYER OF THE YEAR

1. All participating players will receive points from each Player of the Month Tournament (see Player of the Month, section 6)
2. The top 100 point earners will be eligible to play in the \$40,000 Guaranteed Player of the Year Invitational Tournament in January 2013
3. Each player participating in the Player of the Year Tournament will receive 7,500 in tournament chips at the start of the tournament, plus a 2,500 dealer add-on option
4. Prize money for the Player of the Year Tournament will be paid to the top 10 places
5. The winner of the tournament will be named "Pensacola Greyhound Poker Room's Player of the Year"
6. The house fee for the player of the year tournament will be \$5,000. 100% of all entries collected less the house fees will be returned to the players

PAYOUTS

1. When the tournament is down to the final table (not more than 12 players), the remaining players may agree to distribute the prize money differently than the posted payout schedule (the tournament payout schedule is available upon request)
 - a. The agreement must be reached unanimously
 - b. The agreement will end the tournament
2. 100% of the prize money will be returned to the players and will be administered and paid by the Poker Room Management

3. Other prizes including but not limited to trophies or plaques and promotional items may be awarded in addition to the prize money

INDEMNIFICATION AND RELEASE
